The Senate Budget and Appropriations Committee reports favorably Senate Bill No. 2024.

This bill appropriates \$54,357,547,000 in federal funds and \$26,144,171,463 in federal funds for the State budget for Fiscal Year 2024. In accordance with the provisions of Article VIII, Section II, paragraph 2 of the New Jersey Constitution, the Fiscal Year 2024 appropriations bill identifies anticipated resources sufficient to meet project appropriations.

The following compares the recommendations of the Governor's Fiscal Year 2024 revised budget proposal with that of the appropriations bill:
