1	A JOINT RESOLUTION designating the fourth Wednesday in May of
2	each year as "Crisis Professionals Day."
3	
4	WHEREAS, Crisis professionals are trained professionals who engage
5	with people who are experiencing a crisis; and
6	WHEREAS, Crisis professionals directly engage with people when they
7	are most vulnerable, oftentimes as a result of illness and trauma, in
8	effort to deescalate the crisis using methods that center around
9	empathy, support, and hope; and
10	WHEREAS, When engaging with a person who is experiencing a crisis,
11	the crisis professional assesses the situation and implements a
12	course of care so that the children, adults, and families involved can
13	obtain the treatment and support they need and deserve; and
14	WHEREAS, Crisis professionals face high stress situations on a regular
15	basis and as a result have earned the State's highest respect and
16	gratitude; and
17	WHEREAS, As a critical part of the acute care that New Jerseyans
18	receive across the State, crisis professionals engage with New
19	Jerseyans during the most traumatic, stressful, and challenging
20	times of their lives; and
21	WHEREAS, It is fitting to recognize and honor the life changing and
22	lifesaving services that crisis professionals provide, as well as, the
23	invaluable contributions they have provided to thousands of New
24	Jerseyans and communities throughout the State; now, therefore,
25	
26	BE IT RESOLVED by the Senate and General Assembly of the
27	State of New Jersey:
28	
29	1. The fourth Wednesday in May of each year is designated as
30	"Crisis Professionals Day" in the State of New Jersey in order to
31	recognize and honor the importance of crisis professionals and the
32	services they provide as they enhance human wellbeing and mental
33	health, restore functioning, and save lives, by contributing to high
34	quality, context relevant behavioral health services.
35	
36	2. The Governor is respectively requested to annually issue a
37	proclamation recognizing the fourth Wednesday in May of each
38	year as "Crisis Professionals Day" in New Jersey, and calling upon
39	public officials and the citizens of this State to observe the day with
40	appropriate activities and programs.

42	3. This joint resolution shall take effect immediately.
