SYNOPSIS

Requires health insurers and SHBP to provide certain mental health benefits for eating disorders under same terms and conditions as for other illnesses and diseases.

4 **BE IT ENACTED** by the Senate and General Assembly of the State
5 of New Jersey:

7 1. Section 1 of P.L.1999, c.106 (C.17:48-6v) is amended to
8 read as follows:

9 1. a. Every individual and group hospital service corporation
10 contract that provides hospital or medical expense benefits and is
11 delivered, issued, executed or renewed in this State pursuant to
12 P.L.1938, c.366 (C.17:48-1 et seq.), or approved for issuance or
13 renewal in this State by the Commissioner of Banking and
14 Insurance, on or after the effective date of this act shall provide
15 coverage for biologically-based mental illness under the same terms
16 and conditions as provided for any other sickness under the
17 contract.

18 "Biologically-based mental illness" means a mental or nervous
19 condition that is caused by a biological disorder of the brain and
20 results in a clinically significant or psychological syndrome or
21 pattern that substantially limits the functioning of the person with
22 the illness, including but not limited to, schizophrenia,
23 schizoaffective disorder, major depressive disorder, bipolar
24 disorder, paranoia and other psychotic disorders, obsessive-
25 compulsive disorder, panic disorder, eating disorders, and pervasive
26 developmental disorder or autism.

27 "Eating disorders" means all eating disorders, including but not
28 limited to, anorexia, bulimia, and binge-eating disorder.

31 8. a. Every enrollee agreement delivered, issued, executed or
32 renewed in this State pursuant to P.L.1973, c.337 (C.26:2J-1 et seq.)
33 or approved for issuance or renewal in this State by the
34 Commissioner of **【Health and Senior Services】** Banking and
35 Insurance, on or after the effective date of this act shall provide
36 health care services for biologically-based mental illness under the
37 same terms and conditions as provided for any other sickness under
38 the agreement.

39 "Biologically-based mental illness" means a mental or nervous
40 condition that is caused by a biological disorder of the brain and
41 results in a clinically significant or psychological syndrome or
42 pattern that substantially limits the functioning of the person with
43 the illness, including but not limited to, schizophrenia,
44 schizoaffective disorder, major depressive disorder, bipolar
45 disorder, paranoia and other psychotic disorders, obsessive-

13 (2) which providers shall be entitled to reimbursement or to be
14 participating providers, as appropriate, for mental health services
15 under the enrollee agreement.

16 c. The provisions of this section shall apply to enrollee
17 agreements in which the health maintenance organization has
18 reserved the right to change the premium.

21 9. Section 1 of P.L.1999, c.441 (C.52:14-17.29d) is amended to
22 read as follows:

23 1. As used in this act:

24 "Biologically-based mental illness" means a mental or nervous
25 condition that is caused by a biological disorder of the brain and
26 results in a clinically significant or psychological syndrome or
27 pattern that substantially limits the functioning of the person with
28 the illness including, but not limited to, schizophrenia,
29 schizoaffective disorder, major depressive disorder, bipolar
30 disorder, paranoia and other psychotic disorders, obsessive-
31 compulsive disorder, panic disorder, eating disorders, and pervasive
32 developmental disorder or autism.

33 “Eating disorders” means all eating disorders, including but not
34 limited to, anorexia, bulimia, and binge-eating disorder.

35 "Carrier" means an insurance company, health service
36 corporation, hospital service corporation, medical service
37 corporation or health maintenance organization authorized to issue
38 health benefits plans in this State.

39 "Same terms and conditions" means that a carrier cannot apply
40 different copayments, deductibles or benefit limits to biologically-
41 based mental health benefits than those applied to other medical or
42 surgical benefits.

45 10. This act shall take effect on the 90th day after enactment
46 and shall apply to contracts, policies, and enrollee agreements
47 issued or renewed on or after that date.

STATEMENT

This bill requires hospital, medical, and health service corporations; individual, small employer and larger group health insurers; health maintenance organizations; and the State Health Benefits Program to provide insurance coverage for all eating disorders under the same terms and conditions as provided for any other covered sickness.

In 1999, the Legislature enacted two laws to provide insurance coverage for “biologically-based mental illnesses” under the same terms and conditions as for other covered sicknesses, but the definition of that term did not specifically list eating disorders. This bill amends the definition of “biologically-based mental illness” to include “eating disorders,” and defines these disorders as “all eating disorders, including but not limited to, anorexia, bulimia, and binge-eating disorder.”

It is anticipated that this bill will resolve the dispute over whether insurers and health maintenance organizations are required to provide coverage for eating disorders as a biologically-based mental illness. This bill would clarify that the definition of “biologically-based mental illness” includes all eating disorders.
