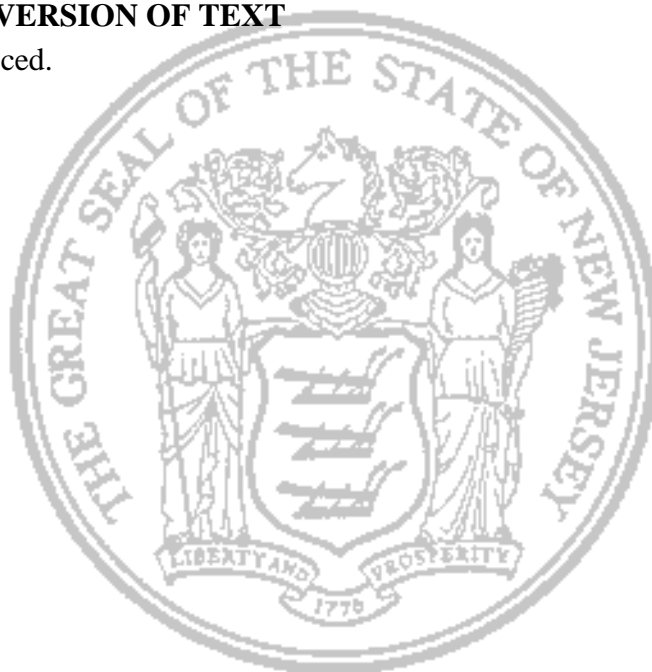

SYNOPSIS

Requires NJT to expand or modify routes and hours of certain transportation services and to solicit input from individuals diagnosed with autism.

1 AN ACT concerning certain New Jersey Transit Corporation
2 transportation services and supplementing Title 27 of the
3 Revised Statutes.

5 **BE IT ENACTED** by the Senate and General Assembly of the State
6 of New Jersey:

8 1. a. Within one year of the effective date of P.L. ,
9 c. (C.) (pending before the Legislature as this bill), the New
10 Jersey Transit Corporation shall expand or modify the routes and
11 hours of motorbus regular route service, paratransit service, and rail
12 passenger service, as those terms are defined pursuant to section 3
13 of P.L.1979, c.150 (C.27:25-3), including light rail service,
14 operated by or under contract to the corporation to accommodate
15 the mobility needs of individuals diagnosed with autism spectrum
16 disorder. Prior to expanding or modifying the routes and hours of
17 these services as required by this subsection, the corporation shall
18 solicit and receive advice, input, and guidance for the expansion or
19 modification from individuals diagnosed with autism spectrum
20 disorder and their advocates.

21 b. The corporation shall solicit and receive advice, input, and
22 guidance from individuals diagnosed with autism spectrum disorder
23 and their advocates on an annual basis to determine whether the
24 routes and hours of motorbus regular route service, paratransit
25 service, and rail passenger service, as those terms are defined
26 pursuant to section 3 of P.L.1979, c.150 (C.27:25-3), including light
27 rail service, operated by or under contract to the corporation
28 adequately accommodates the mobility needs of individuals
29 diagnosed with autism spectrum disorder and whether further
30 expansion or modification of the routes and hours are necessary.

32 2. This act shall take effect immediately.

35 STATEMENT

37 This bill requires the New Jersey Transit Corporation
38 (corporation) to expand or modify the routes and hours of motorbus
39 regular route service, paratransit service, and rail passenger service,
40 including light rail service, to accommodate the mobility needs of
41 individuals diagnosed with autism spectrum disorder within one
42 year of the effective date of the bill. The corporation is required to
43 solicit and receive advice, input, and guidance from individuals
44 diagnosed with autism spectrum disorder and their advocates before
45 the corporation expands or modifies the routes and hours of service.

46 The bill also requires the corporation to solicit and receive, on an
47 annual basis, advice, input, and guidance from individuals
48 diagnosed with autism spectrum disorder and their advocates. The

2 whether the routes and hours of motorbus regular route service,
3 paratransit service, and rail passenger service, including light rail
4 service, adequately accommodates the mobility needs of individuals
