**SYNOPSIS**

Provides for postponement of New Jersey Quality Single Accountability Continuum review for certain school districts for 2021-2022 school year.

1 AN ACT concerning the New Jersey Quality Single Accountability  
2 Continuum and supplementing P.L.1975, c.212 (C.18A:7A-3 et  
3 seq.).

5 **BE IT ENACTED** by the Senate and General Assembly of the State  
6 of New Jersey:

8 1. a. (1) Notwithstanding the provisions of section 11 of  
9 P.L.1975, c.212 (C.18A:7A-11) or any other section of law to the  
10 contrary, the Department of Education shall postpone the  
11 comprehensive review under the New Jersey Quality Single  
12 Accountability Continuum of any school district that:

13 (a) is required to undergo a comprehensive review in the 2021-  
14 2022 school year; and

15 (b) was designated as a high performing district pursuant to  
16 section 14 of P.L.1975, c.212 (C.18A:7A-14) in the school district's  
17 most recent comprehensive review.

18 (2) Notwithstanding the provisions of this subsection to the  
19 contrary, the Commissioner of Education shall permit a school district  
20 that is subject to the postponement of a comprehensive review under  
21 paragraph (1) of this subsection to undergo a comprehensive review in  
22 the 2021-2022 school year, upon request by the school district. A  
23 school district that undergoes a comprehensive review in the 2021-  
24 2022 school year pursuant to this paragraph shall undergo its next  
25 comprehensive review three years after the 2021-2022 school year.

26 b. If the comprehensive review of a school district is postponed  
27 under paragraph (1) of subsection a. of this section, then the school  
28 district shall undergo its next comprehensive review three years after  
29 the school year in which its comprehensive review was originally  
30 scheduled to take place.

31 c. A school district that is required to undergo a comprehensive  
32 review in the 2021-2022 school year and was not designated as a high  
33 performing district pursuant to section 14 of P.L.1975, c.212  
34 (C.18A:7A-14) in the school district's most recent comprehensive  
35 review shall undergo a comprehensive review under the New Jersey  
36 Quality Single Accountability Continuum in the 2021-2022 school  
37 year, except that such a district may postpone its comprehensive  
38 review until the 2022-2023 school year if the district provides written  
39 notification to the Commissioner of Education that it is not able to  
40 complete the review due to the impacts of the COVID-19 pandemic.

41 d. If a school district postpones its comprehensive review until the  
42 2022-2023 school year pursuant to subsection c. of this section, then  
43 the school district shall undergo its next following comprehensive  
44 review three years after the school year in which its comprehensive  
45 review was originally scheduled to take place.

1       2. This act shall take effect immediately.

STATEMENT

6       This bill postpones the comprehensive review of certain school  
7 districts under the New Jersey Quality Single Accountability  
8 Continuum (NJQSAC) for the 2021-2022 school year.

9       Under current law, each school district is required to undergo a  
10 comprehensive review under the State monitoring system, the  
11 NJQSAC, once every three years according to a schedule  
12 established by the Commissioner of Education. As a result, only a  
13 certain number of school districts undergo monitoring during any  
14 given year.

15       Under this bill, the comprehensive review of certain districts  
16 would be postponed to allow school districts and the Department of  
17 Education to focus additional resources on addressing issues related  
18 to the COVID-19 pandemic. The bill would postpone until the  
19 2024-2025 school year the comprehensive review of districts that:  
20 (1) are required to undergo a comprehensive review in the 2021-  
21 2022 school year; and (2) were designated as a high performing  
22 district pursuant to section 14 of P.L.1975, c.212 (C.18A:7A-14) in  
23 the school district's most recent comprehensive review. However,  
24 the Commissioner of Education is required to permit a high  
25 performing school district that is subject to postponement under the  
26 bill to undergo a comprehensive review in the 2021-2022 school  
27 year, upon request by the school district.

28       This bill requires a school district that is scheduled to undergo a  
29 comprehensive review in the 2021-2022 school year and was not  
30 designated as a high performing district in the school district's most  
31 recent comprehensive review to undergo the 2021-2022 NJQSAC as  
32 scheduled, except that such a district may postpone its  
33 comprehensive review until the 2022-2023 school year if the district  
34 provides written notification to the Commissioner of Education that  
35 it is not able to complete the review due to the impacts of the  
36 COVID-19 pandemic. A school district that postpones its  
37 comprehensive review pursuant to this exception would be required  
38 to undergo its next review as if the postponement had not occurred  
39 (i.e., three years after the school year in which the review was  
40 originally scheduled to take place).
