Prohibits discrimination against individuals who have not received COVID-19 vaccine.

1 AN ACT concerning COVID-19, immunizations, and discrimination  
2 and supplementing Title 10 of the Revised Statutes.

4 **BE IT ENACTED** by the Senate and General Assembly of the State  
5 of New Jersey:

7 1. a. Notwithstanding any law, rule, regulation, or executive  
8 order to the contrary, it shall be unlawful to ask any individual if  
9 the individual has received a coronavirus disease 2019 (COVID-19)  
10 vaccine, to require any individual to receive a COVID-19 vaccine,  
11 or to require any individual to show proof of having received a  
12 COVID-19 vaccine as a condition of or as a prerequisite to:

13 (1) the exercise of any privilege or right granted under State or  
14 federal law;

15 (2) conducting any business or commerce;

16 (3) travelling to, outside, or within the State;

17 (4) obtaining or maintaining an internship, obtaining or  
18 maintaining employment, or receiving a promotion from an  
19 employer;

20 (5) participation in any governmental or political activity;

21 (6) admission or enrollment into any child or adult day care  
22 program;

23 (7) admission to, enrollment in, or graduation from a preschool  
24 program, elementary or secondary school, college, university, or  
25 any other institution of education;

26 (8) participation in any activity, internship, opportunity,  
27 program, or sport offered by a preschool program, elementary or  
28 secondary school, college, university, or any other institution of  
29 education;

30 (9) receiving adequate dental care or health care;

31 (10) maintaining, receiving, or renewing a professional  
32 certification or license;

33 (11) obtaining or renewing membership in any professional  
34 organization;

35 (12) entrance into or service from any place of business,  
36 including, but not limited to, any market, restaurant, or store;

37 (13) entrance into and service from any public building, office,  
38 or structure;

39 (14) entrance into and use of any public park or beach; or

40 (15) admission into or service from any amusement park,  
41 concert venue, theater, or sporting event.

42 b. It shall be unlawful to discriminate against or to take any  
43 adverse action against any individual who has not received a  
44 COVID-19 vaccine or who does not disclose whether the individual  
45 has received a COVID-19 vaccine.

47 2. An individual who violates the provisions of this act shall, in  
48 addition to any other relief authorized by law, be liable for civil

1 damages to the victim in the amount of \$25,000 in an action  
2 brought in the Superior Court in the county where the offense  
3 occurred. In addition to an award of civil damages, the court shall  
4 order the defendant to pay such attorney's fees or expenses, or both,  
5 that are actually and reasonably incurred by the victim who is the  
6 successful party in the action.

8 3. This act shall take effect immediately.

STATEMENT

12

13 This bill prohibits discrimination against individuals who have  
14 not received a COVID-19 vaccine.

15 Under the bill, it is to be unlawful to ask any individual if the  
16 individual has received a coronavirus disease 2019 (COVID-19)  
17 vaccine, to require any individual to receive a COVID-19 vaccine,  
18 or to require any individual to show proof of having received a  
19 COVID-19 vaccine as a condition of or as a prerequisite to:

20 (1) the exercise of any privilege or right granted under State or  
21 federal law;

22 (2) conducting any business or commerce;

23 (3) travelling to, outside, or within the State;

24 (4) obtaining or maintaining an internship, obtaining or

**S125 HOLZAPFEL**

1       The bill provides that it is to be unlawful to discriminate against  
2 or to take any adverse action against any individual who has not  
3 received a COVID-19 vaccine or who does not disclose whether the  
4 individual has received a COVID-19 vaccine. An individual who  
5 violates the provisions of this bill is to, in addition to any other  
6 relief authorized by law, be liable for civil damages to the victim in  
7 the amount of \$25,000 in an action brought in the Superior Court in  
8 the county where the offense occurred. In addition to an award of  
9 civil damages, the court is to order the defendant to pay such  
10 attorney's fees or expenses, or both, that are actually and reasonably  
11 incurred by the victim who is the successful party in the action.
